MUNICIPAL ORDINANCE NO. 504

AN ORDINANCE REQUIRING ALL TENANTS IN THE SOLSONA PUBLIC
MARKET TO PROVIDE THEMSELVES WITH THEIR OWN INDIVIDUAL
TRASH BIN AND PROVIDING PENALTIES IN VIOLATION THEREOF.

WHEREAS, it has been observed that at the end of every market day there
are lots of garbages scattered all over the market area;

WHEREAS, the pile of garbages being scattered around are not only
eyesore to the public but also become as breeding place for insects that could spread
communicable diseases;

WHEREAS, the utility workers would have easier and faster time in the
collection of garbages if all garbages shall be placed in trash bins and (vendor)
responsible to see to it that their respective stalls/ premises are clean and orderly;

WHEREAS, there shall be a separate collection of biodegradable and non-
biodegradable wastes and garbages;

NOW THEREFORE, on motion of Hon. Ismael L. Agulay, duly seconded by
Hon. Jovencio M. Pascua, be it enacted that:

Section 1 - All tenants in the public market are required to have trash bin for
themselves where to keep their refused matters and see to it that their stalls and
premises are clean and in order;

Section 2 - Penalty Provision:

This ordinance will stipulate a penalty of ONE HUNDRED PESOS
(P 100.00) fine or community service of one day or less, or both at the discretion of
the court (Community Service may include sweeping or cleaning at the market area
and other related activities to the Public).

Section 3 - This ordinance shall repeal all existing ordinances in part or in
whole;

Section 4 - This ordinance shall take effect upon approval and all the
provisions of the Local Government Code pertaining to shall be complied with.
