MUNICIPAL ORDINANCE NO. 505

AN ORDINANCE AMENDING CHAPTER IV, ARTICLE C, SECTION 4C.01 OF THE  
REVENUE TAX CODE OF SOLSONA, ILOCOS NORTE. INCREASING POLICE  
CLEARANCE FEE.

On motion of Hon. Ismael L. Agulay, duly seconded by Hon. Jovencio M. Pascua, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - the Police Clearance Fee be increased as follows:

- For employment, Scholarships, Study Grants and other Purposes not hereunder specified from P10.00 to P 40.00.
- For change of Name from P30.00 to P 80.00.
- For Firearms Permit application from P30.00 to P100.00.
- For passport or Visa Application from P40.00 to P60.00
- Application for Filipino Citizenship from P100.00 to P200.00.

Section 2 - The fee shall be paid to the Municipal Treasurer or her duly authorized representative upon application for the Police Clearance Certificate;

Section 3 - Any ordinance contrary or in conflict with the foregoing provisions are hereby repealed or resigned;

Section 4 - This Ordinance shall take effect after the lapse of ten (10) days after posting a copy thereof in the Municipal Bulletin Board, Churches and Barangay Hall, and be published in the local newspaper in three (3) consecutive weeks;


