MUNICIPAL ORDINANCE NO. 507

AN ORDINANCE AMENDING CHAPTER IV, ARTICLE A, SECTION 4A-01 OF THE
REVENUE TAX CODE OF SOLSONA, ILOCOS NORTE, INCREASING SECRETARY'S
FEES.

On motion of Hon. Alma B. Manuel, duly seconded by Hon. Ismael L. Agulay and
Hon. Jovencio M. Pascua, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - IMPOSITION OF FEES - There shall be collected the following fees from
every person requesting for copies for official records and documents from Offices of the
Municipal Government of Solsona, Ilocos Norte:

1. For every page or fraction thereof, typewritten from P5.00 to P30.00
2. Where the copy to be furnished is in printed form in whole or in part for each page
(double this fee if there are two pages in a sheet) from P5.00 to P20.00;
3. For certifying the Officials Act of a Municipal Judge or other judicial certificate
with seal from P30.00 to P50.00;
4. For each certificate of correctness (with seal of office) written on the copy or
attached thereto from P10.00 to P50.00;
5. For certified copies of any paper, record or decree, judgement or entry of which
any person is entitled to demand and receive a copy (in connection with judicial proceedings
for each page from P10.00 to P30.00;
6. Xerox copy or any other produced by copying machine per page from P10.00 to
P15.00;

7. Photo copy per page from P5.00 to P30.00

8. Fees to be imposed by the Assessors:

a. Certified true copy from the Office file from P10.00 to P30.00 (Additional Copy of the Original from P2.00 to P5.00)

b. Certification of real property ownership from P10.00 to P20.00

c. Amortization Fee of Tax Declaration for Purposes of Bail Bond from P5.00 to P30.00

9. For other certifications, each certificate office issued by Page from P10.00 to P30.00

Section 2 - Any Ordinance contrary or in conflict with the foregoing provisions are hereby repealed or rescind.

Section 3 - This Ordinance shall take effect upon approval and after posting copies in three conspicuous places and all the provisions of the Local Government Code pertaining to shall be complied with.


