MUNICIPAL ORDINANCE NO. 508

AN ORDINANCE CREATING THE POSITION OF TAX MAPPING AIDE AND DEFINING ITS  
FUNCTIONS UNDER THE OFFICE OF THE MUNICIPAL ASSESSOR, SOLSONA, ILOCOS NORTE.

WHEREAS, additional personnel under the Office of the Municipal Assessor is needed to help  
carry out various office works;

WHEREAS, the Assessor's Office is undermanned with only one position still created under the  
taxmapping division which shall ensure the implementation of the Real Property Tax Administration  
(RPTA) project;

NOW THEREFORE, on motion of Hon. Ismael L. Agulay, duly seconded by Hon. Gervacio B.  
Vicente and Hon Jovencio M. Pascua, be it

ORDAINED, by the Sangguniang Bayan of Solsona, that :

Section 1 - The position of Tax Mapping Aide, Salary Grade 4 under the Office of the Municipal  
Assessor is hereby created;

Section 2 - The Tax Mapping Aide shall be under the Tax Mapping Division who shall be  
responsible for recording necessary notations on the basemaps and traces property boundary lines on the  
rectified aerial photo on mapboards;

Section 3 - This ordinance shall take effect immediately upon approval;

Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City, the Civil  
Service Commission, Provincial Branch, Heroes Hall, Laoag City for their approval;

Against: None.


