MUNICIPAL ORDINANCE NO. 99-509

AN ORDINANCE AMENDING SECTION 4, LETTER C AND D OF ORDINANCE NO. 44, SERIES OF 1992 INCREASING THE FRANCHISE FEE FROM ONE HUNDRED THIRTY PESOS (P130.00) TO TWO HUNDRED FIFTY PESOS (P250.00) AND INCREASING THE SERVICE FEE/INSPECTION FEE FROM TWENTY PESOS (P20.00) TO ONE HUNDRED PESOS (P100.00).

WHEREAS, pursuant to its legislative authority, the Sangguniang shall subject to the guidelines prescribed by the DOTC, regulate the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction of the municipality;

NOW THEREFORE, on motion of Hon. Gervacio B. Vicente, duly seconded by Hon. Jovencio M. Pascua and Hon. Faustino H. Valdez Jr., be it

ENACTED, by the Sangguniang Bayan of Solsona, that:

Section 1 Section 4, letter C and D of Ordinance No. 44 Series of 1992 presently read the following requirements in securing Municipal Franchise to Operate Public Utility Tricycle.

Letter C - Franchise Fee of P130.00
D - Inspection Fee of P20.00

Section 2 - The above Section 4 Letter C and D are hereby amended to be read as franchise fee of TWO HUNDRED FIFTY PESOS (P250.00) and ONE HUNDRED PESOS (P100.00) as inspection fee.

Section 3 - The fee shall be paid to the Municipal Treasurer before the issuance of the franchise.

Section 4 - Other parts or provision of any existing Ordinance which are not affected thereby shall continue to be in full force and in effect.


Section 5 - This Ordinance shall take effect immediately on the day following the lapse of 21 days posting period and publication in three (3) consecutive weeks in the newspaper for local circulation.

Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City and others concerned for their information and consideration;


