MUNICIPAL ORDINANCE NO. 51

AN ORDINANCE REGULATING THE ISSUANCE OF BUSINESS PERMITS
LIMITED TO APPLICANTS OF PERMANENT, TEMPORARY STALLS
AND VACANT LOTS OWNED BY THE MUNICIPALITY WITHIN THE
MUNICIPALITY OF SOLSONA.

WHEREAS, Solsona is fast becoming a center of trade
in the Eastern part of Ilocos Norte;

WHEREAS, we are aware that "Business is a Free Enter-
prise" however, residents of this municipality be given prio-
rity to lease municipality owned business establishments;

WHEREFORE, on motion of Sangguniang Bayan Gervacio
Vicente, duly seconded by Hon. Rogerio Teodoro, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos
Norte that;

Section 1 - The issuance of permits to engage in busi-
ness within the Municipality of Solsona be regulated;

Section 2 - The lease of stalls, (permanent or temporary)
lots, owned by the Municipality should prioritize residents of
this Municipality.

Section 3 - This ordinance shall take effect with the
lapse of TEN days (10) from the date a copy of this Ordinance
is posted in a bulletin board and other conspicuous place;

Voting on the foregoing measure as follows:

In favor - Member: Teodoro, Vicente, Ganal, Agulay,
Estavillo and Refani.

Against - Member: Batara

Abstain - Member: Pascua and Luis
