MUNICIPAL ORDINANCE NO. 99-511

AN ORDINANCE REQUIRING EMPANADA, BALOT, FISHBALLS AND BARBECUE VENDORS TO OCCUPY THE NORTHERN PORTION OF THE NEW MARKET STALLS AND DESIGNATING THE SAME AS PERMANENT AREA FOR THAT PURPOSE AND PROVIDING PENALTIES IN VIOLATION THEREOF.

WHEREAS, it is imperative to require Empanada, Balot, Fishballs and Barbecue Vendors to occupy the northern portion of the new market stalls and designating the same as the permanent area for that purpose for a more orderly and sanitary premises, as embodied in the Clean and Green Program;

WHEREAS, this move seeks to make collection of fees and taxes due easier;

WHEREFORE, on motion of Hon. Alma B. Manuel, seconded by Hon. Jovencio M. Pascua, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - All Empanada, Balot, Fishballs and Barbecue Vendors are hereby required to occupy the northern portion of the new market stalls and designating the same as permanent area for that purpose;

Section 2 - Any vendor who shall not comply with this Ordinance will be fined of not less than FIVE HUNDRED PESOS (P500.00) but not more than ONE THOUSAND PESOS (P1,000.00) or both fine and imprisonment depending upon the discretion of the court;

Section 3 - This Ordinance shall take effect after the lapse of 21 days after posting copies in a conspicuous places, in the Municipal Hall, Public Market and Church and publication in three consecutive weeks in the newspaper of local circulation;

Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City and the Municipal Treasurer, Solsona, Ilocos Norte, for their information and consideration;
