MUNICIPAL ORDINANCE NO. 99-512

AN ORDINANCE DESIGNATING AREAS AND TIME FOR LOADING AND UNLOADING OF DRY GOODS AND BAGSAKAN FOR WET GOODS AGRICULTURAL PRODUCTS, AT THE PUBLIC MARKET AND PROVIDING PENALTIES IN VIOLATION THEREOF.

WHEREAS, it has been observed that many vendors slip goods into the market compound "through over the fence" or other entrances not manned by a Market Collector just to evade paying of market fees;

WHEREAS, market collections decrease because of this rampant practices of some market vendors;

WHEREAS, passage of this Ordinance will increase the collection in the market and will also lessen the number of market collectors manning the market;

WHEREAS, designating a specific "Bagsakan" for agricultural products, wet goods and dry goods will also prevent the competition of the "compradors" and the market-goers in buying from the market vendors inside the market compound;

NOW THEREFORE, on motion of Hon. Antonio Q. Gallegos, duly seconded by Hon. Andresito A. Luis, be it ENACTED by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - There is hereby designated the eastern gate (Gate No. 1) of the Public Market as loading and unloading for dry goods and eastern gate (Gate No. 2) as bagsakan for vegetables and other agricultural products, and also at the northern gate (Gate No. 3) as bagsakan for wet goods and designating further that these gates be the official entrances for vendors where they will pay their market fees;

Section 2 - The time for market vendors to drop their goods within the designated "bagsakan" is from 4:00 A.M. to 7:30 A.M. for Wholesaler and 6:00 A.M. to 12:00 noon for retailer;

Section 3 - The "compradors" are only allowed to engage in business with wholesaler at the bagsakan from 4:00 A.M. to 7:30 A.M. only;

Section 4 - Anybody who violates any provision of this Ordinance shall be penalized by a fine of not less than ONE HUNDRED PESOS (P100.00) but not more than FIVE HUNDRED (500.00) or both fine and imprisonment depending upon the discretion of the Court;

Section 5 - This Ordinance shall take effect after the lapse of twenty-one (21) days upon posting in three conspicuous places and after publication in a newspaper of local circulation in three consecutive weeks;


Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City, the Municipal Treasurer, Solsona, Ilocos Norte and others concerned for their information and consideration;
