MUNICIPAL ORDINANCE NO. 99-513

AN ORDINANCE FORMULATING PROGRAM FOR THE WELFARE AND  
PROTECTION AGAINST CHILD ABUSE EXPLOITATION AND DISCRIMINATION.

WHEREAS, it is often read in the newspaper, seen in television and heard in the radio  
broadcast that an epidemic of all forms of child abuse is sweeping in the country;

WHEREAS, in anticipation of the foregoing menace to children, the Municipal  
Government of Solsona, Ilocos Norte, had decided to formulate a program to collaborate with  
the policy/principles and IRR embodied in Republic Act 7658 as amended;

NOW THEREFORE, on motion of Hon. Gervacio B. Vicente, duly seconded by Hon.  
Alma B. Manuel and Hon. Jovencio M. Pascua, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - The Municipal Government of Solsona shall formulate a program for the  
welfare and protection against child abuse, exploitation and discrimination;

Section 2 - There shall be composed of committees and sub-committees that shall run  
the activities of the program:

1.1. Organize Municipal Sub-Committee for the welfare of children.

2.2. Organize Barangay Council for the protection of child:

- a. Family care and alternative parental arrangement.
- b. Basic health, nutrition, social security and safe environment.
- c. Basic education, leisure and cultural activities.
- d. Protection of children in especially difficult circumstances.
- e. Fundamental civil rights.

3.3. Coordinating Committee shall be composed of the Municipal Mayor, Sangguniang Bayan Representative, Chairman of the Committee on Health, concerned NGO's, PNP Personnel Representative, Municipal Social Worker, Municipal Health Officer and Punong Barangays.


Section 3 - This Ordinance shall take effect immediately upon approval;

Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City for their information and consideration;


