MUNICIPAL ORDINANCE NO. 99-515

AN ORDINANCE REQUIRING THE TWENTY-TWO (22) BARANGAYS OF THE MUNICIPALITY OF
SOLSONA, ILOCOS NORTE TO HAVE THEIR OWN BARANGAY OFFICIAL SEAL.

WHEREAS, it is an imperative need that every barangay of Solsona, Ilocos Norte is required to
have its own official seal for proper identification;

NOW THEREFORE, on motion of Hon. Cresencio M. Viloría, duly seconded by Hon. Gervacio B.
Vicente, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - Every barangay of Solsona, Ilocos Norte is hereby required to have an Official Seal;

Section 2 - The color and symbol of the Official Seal shall feature the most important place and
activity that play an important role in the development of the barangay;

Section 3 - This Ordinance shall take effect immediately upon approval;



MUNICIPAL ORDINANCE NO. 99-514

AN ORDINANCE PENALIZING TRICYCLE DRIVERS OPERATING WITHIN THE JURISIDCTION OF SOLSONA, ILOCOS NORTE FOR REFUSING CONVEYANCE AND PROVIDING PENALTIES IN VIOLATION THEREOF.

WHEREAS, it has been reported to this office that oftentimes tricycle drivers refused to pick-up passenger or select their passenger;

WHEREFORE, on motion of Hon. Faustino H. Valdez, Jr., duly seconded by Hon. Gervacio B. Vicente and Hon. Jovencio M. Pascua, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - Any tricycle drivers operating within the jurisdiction of Solsona, Ilocos Norte, who refuses to pick-up or select their passengers shall be penalized is hereby enacted;

Section 2 - A fine of not less than TWO HUNDRED PESOS (P200.00) shall be imposed in violation thereof;

Section 3 - This Ordinance shall take effect immediately upon approval and upon posting in three conspicuous places for 21 days and after publication in a newspaper of local circulation in three consecutive weeks;


