MUNICIPAL ORDINANCE NO. 99-519

AN ORDINANCE CREATING THE POSITION OF SECRETARY II (A), SALARY GRADE 9 UNDER
THE OFFICE OF THE SANGGUNIANG BAYAN.

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - There is hereby created in the Office of the Sangguniang Bayan, the position of Secretary II (A), Salary Grade 9, whose duties and functions shall be in line with the existing rules, laws and regulations imposed by the Civil Service Commission;
