MUNICIPAL ORDINANCE NO. 52

AN ORDINANCE IMPOSING NEW RATES OF MARKET RENTAL FEES.

WHEREAS, with the effectivity of the new Local Government Code of 1991, revenue sources has now been primarily relied on the local collections besides Internal Revenue Allotment (IRA);

WHEREAS, a need to raise our local reserves particularly on our local collections, with the purpose not to over-tax the citizenry, but to pinpoint on our taxes/fees that need codification/legal increase;

WHEREAS, the maintenance of the market could hardly be shouldered by the Local Government Unit;

NOW THEREFORE, on motion of Hon. Teodoro duly seconded by Hon. Pascua, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - This Ordinance shall be referred to as "New Rates of Market rental fees";

Section 2 - The new rates of market rental fees are as follows:

<u>PUBLIC MARKET</u>	<u>PRESENT COLLECTION</u>	<u>NEW RATES</u>
1. Meat Section	No fee collected	P50.00/sq.m./mo.
2. Fish Stalls	No fee collected	30.00/sq.m./mo.
3. Vegetable stalls and other food section ^a	No fee collected	15.00/sq/m/ mo.

Section 3 - Time and Manner of payment - The payment of monthly rental shall be within the first twenty days (20) of each month. In case of a new lease, the rental due for the month in which the lease starts, shall be paid before occupancy of the stall;

Section 4 - This Ordinance shall take effect after the lapse of ten days (10) from the day a copy of it is posted in a bulletin board located in a conspicuous place at the Municipal Hall, Public Market and at the Roman Catholic Church and upon a publication in a newspaper as required by law;




