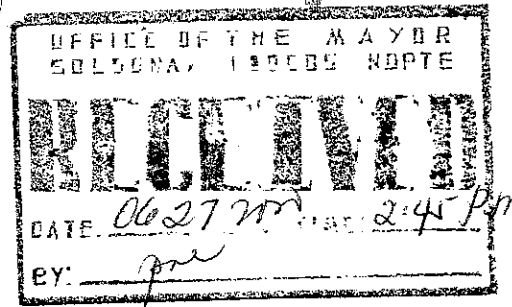

MUNICIPAL ORDINANCE NO. 2000-520

AN ORDINANCE APPREHENDING SMOKE BELCHING VEHICLES OPERATING AND/OR PLYING ALONG THE THOROUGHFARES/HIGHWAYS WITHIN THE JURISDICTION OF THE MUNICIPALITY OF SOLSONA AND PROVIDING PENALTY THEREOF.

WHEREAS, smoke emitted by vehicles composed of chemicals like carbon monoxide and other intoxicating gases causes great danger to our environment which leads to the destruction of the ozone layer (Green House Effect) causing harmful effect to human beings;

WHEREAS, the municipal government is very much aware of the health condition of its constituents;

WHEREAS, smoke belching vehicles are contributory to the degradation of our clean air, thus, all vehicles considered smoke belchers shall not be allowed to ply the routes within the jurisdiction of the Municipality of Solsona, Ilocos Norte;

NOW THEREFORE, on motion of Hon. Ismael L. Agulay, duly seconded by Hon. Andresito A. Luis, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - All smoke belching vehicles operating and/or plying along the thoroughfares/highways within the jurisdiction of the Municipality of Solsona, Ilocos Norte shall be apprehended;

Section 2 - Penalty provisions:

First Offense - Vehicle will be apprehended, Operator/Driver are instructed to tune-up their vehicle;

Second Offense - Operators and/or Drivers shall be penalized in the amount of THREE HUNDRED PESOS (P300.00) to FIVE HUNDRED PESOS (P500.00);

Third Offense - Vehicle shall be impounded or penalized in the amount of ONE THOUSAND PESOS (P1,000.00) or both based on the discretion of the court;

Section 3 - Implementing agency - the Philippine National Police (PNP) Personnels shall be the implementing agency assisted by all accredited Peacekeeping Agencies/Barangay Tanods;

Section 4 - This Ordinance shall take effect after the lapse of 21 days upon posting in three conspicuous places;


Copies of this Ordinance be furnished the Philippine National Police of Solsona, the Municipal Treasurer of Solsona, the 22 Barangays of Solsona and the Sangguniang Panlalawigan, Laoag City, for their information and consideration;
