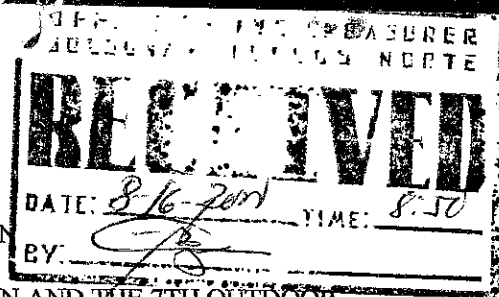

MUNICIPAL ORDINANCE NO. 2000-522

AN ORDINANCE REQUIRING ALL PERSONS ENGAGED IN BUYING AND SELLING PIGLETS WITHIN THE MUNICIPALITY OF SOLSONA TO PAY BUSINESS TAX AND SECURE CORRESPONDING PERMITS BEFORE OPERATION.

On motion of Hon. Cresencio M. Viloría, duly seconded by Hon. Gervacio B. Vicente, be it

ENACTED, by the Sangguniang Bayan of Solsona, Ilocos Norte in session assembled, that:

Section 1 - There shall be collected business tax with the following schedule:

a. For newly started business - 1/5 of 1% of the total capital employed for the first quarter operation and 1/2 of 1% of the gross receipts of the preceding quarter for the succeeding quarter;

b. For Renewal - 1/2 of 1% of the total gross receipts of the preceding year;

Section 2 - Time and manner of payment: For the newly started business such taxes shall be paid within twenty (20) days before operation. For renewal of business, tax shall be paid within the first twenty days of January which shall be paid to the Municipal Treasurer of his authorized representative;

Section 3 - Fines and penalties - Failure to pay within the prescribed period shall pay 25% surcharge of the total tax due plus 2% penalty for every month of delay;

Any person engaged violating this Ordinance shall be fine by not less than ONE THOUSAND PESOS (P1,000.00) but not more than FIVE THOUSAND PESOS (P5,000.00) and shall be banned to the market premises to sell his goods;

Section 4 - This Ordinance shall take effect upon approval and after the lapse of 21 days posting in at least three (3) conspicuous places;



CARRIED UNANIMOUSLY, with the following votes:




