MUNICIPAL ORDINANCE NO. 2000-525

AN ORDINANCE REGULATING THE NUMBERING OF ALL DIFFERENT BUSINESS ESTABLISHMENTS, RESIDENTIAL HOUSES, COMMERCIAL AND OTHER BUILDINGS WITHIN THE JURISDICTION OF SOLSONA, ILOCOS NORTE.

WHEREAS, pursuant to the provision of RA 7160 otherwise known as the Local Government Code of 1991, the Sangguniang Bayan is empowered to regulate the numbering of residential houses, commercial and other buildings;

WHEREAS, numbering of all business establishment is very essential in many aspect;

NOW THEREFORE, on motion of Hon. Gervacio B. Vicente, duly seconded by Hon. Andresito A. Luis, Hon. Cresencio M. Viloría and Hon. Jovencio M. Pascua, be it

ORDAINED, by the Sangguniang Bayan in session, that:

Section 1 - Every business establishment, residential houses, commercial and other buildings within the jurisdiction of Solsona, Ilocos Norte shall be assigned respective number and is hereby regulated;

Section 2 - The numbering of residential houses and other establishments in the urban barangays shall be by street and the numbering in the rural barangay shall be by sitio with contineous numbering:

EXAMPLE:

Urban -

#21 Washington Street, Juan, Solsona, Ilocos Norte

#30 Sitio Ir-ir, Juan, Solsona, Ilocos Norte

Rural -

#21 Sitio 3, Darasdas, Solsona, Ilocos Norte

Section 3 - The numbering of houses and other establishments start at an extreme point going to the other extreme point in ascending number.

Section 4 - This Ordinance shall take effect immediately upon approval;

Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City for their information and consideration;


