MUNICIPAL ORDINANCE NO. 53

AN ORDINANCE IMPOSING PARKING FEES TO ALL ANIMAL DRAWN AND  
MOTORIZED VEHICLES PARKED ALONG THE ROAD AND DESIGNATED PARK-  
ING AREAS.

On motion of Hon. Luis B. Ganal, duly seconded by  
Hon. Henry A. Batara, be it

ORDAINED, by the Sangguniang Bayan of Solsona,  
Ilocos Norte, that:

Section 1 - Imposition of Fees - Parking fees are  
hereby imposed to all animal drawn and motorized vehicles  
park on all roads authorized as parking areas within one  
hundred (100 m) meters radius of the Solsona Public Market,  
as follows:

| <u>Parking Fees Per Day</u> |        |
|-----------------------------|--------|
| Calesa                      | - ₱.50 |
| Tricycle                    | - 1.00 |
| Jeepneys/Mini Bagon         | - 2.00 |
| Freight/Delivery Truck      | - 3.00 |
| Cars & Jeepney Vendors      | - 1.00 |
| Culiglig                    | - 2.00 |

Section 2 - Time of Payment - The fees imposed herein  
shall be paid to the Municipal Treasurer or her duly authorized  
representative upon parking therein;

Section 3 - Any violation of the provisions of this  
Ordinance shall be fined of not less than FIFTY PESOS (₱50.00)  
but not exceeding ONE HUNDRED PESOS (₱100.00) or an imprison-  
ment of not less than ten (10) days but not exceeding twenty  
(20) days or both at the discretion of the Court;

Section 4 - This Ordinance shall take effect after  
the lapse of ten (10) days upon posting copies in three (3)  
conspicuous places in the Municipal Hall, Public Market and  
Catholic Church;

Voting on the foregoing Ordinance as follows:
