MUNICIPAL ORDINANCE NO. 2001-533

AN ORDINANCE AMENDING ORDINANCE NO. 19, SERIES OF 1989, REQUIRING DRIVERS OF TRICYCLES FOR HIRE PLYING WITHIN THE JURISDICTION OF THE MUNICIPALITY TO WEAR DECENT CLOTHING AND PROVIDING PENALTIES IN VIOLATION THEREOF.

WHEREAS, it is proper and fitting to prohibit tricycle drivers to use undershirts, slippers or anything else that may cause unpleasing reaction or feeling from any commuter particularly to visitors and tourists who use to hire tricycles in going to their destination;

WHEREAS, decency in clothing of an individual driver reflects his personality and actuations;

WHEREFORE, on motion of Hon. Faustino H. Valdez, Jr., duly seconded by Hon. Adlai C. Factora, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - it is unlawful for any driver of tricycle for hire plying within the jurisdiction of the Municipality of Solsona, Ilocos Norte, to wear undershirt, shortpant and slippers;

Section 2 - drivers of tricycles plying for hire in the Municipality of Solsona, shall wear decent clothing, shirts (short or long sleeves, long pants and shoes (rubber or leather, etc.);

Section 3 - Exemptions - during rainy season, drivers are allowed to wear slippers or sandals only when rain occurs;

Section 4 - any driver of tricycles plying for hire within the jurisdiction of the Municipality of Solsona, shall be fined for ONE HUNDRED PESOS (P100.00) for the first offense, ONE HUNDRED FIFTY PESOS (P150.00) for the second offense and FIVE HUNDRED PESOS (P500.00) for the last offense and imprisonment of not less than one (1) month but not more than six (6) months or both fine and imprisonment upon the discretion of the court;



Section 5 - this ordinance shall take effect after the lapse of twenty-one (21) days from the date a copy thereof is posted in the Municipal Bulletin Board and in at least three (3) conspicuous places in the municipality;

Section 6 - all existing provisions of Ordinance No. 19, series of 1989 in conflict with, or in consistent with any provisions of this Ordinance are hereby repealed or modified;


Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City, the STODA President, Solsona, Ilocos Norte and all others concerned for their information;




