MUNICIPAL ORDINANCE NO. 2003-538

AN ORDINANCE SUPPLEMENTING MUNICIPAL ORDINANCE NO. 2001-534 OF THE MUNICIPALITY OF SOLSONA FOR THE UTILIZATION OF THE 20% ADMINISTRATIVE COST FROM THE PHILHEALTH CAPITATION FUND ENSUING FROM THE PROCEEDS OF THE OUTPATIENT CONSULTATION AND DIAGNOSTIC BENEFIT PACKAGE PROVIDED BY THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH).

WHEREAS, the utilization of the 20% administrative cost from the PHILHEALTH Capitation Fund was not acknowledged nor affirmed in the provisions of the Municipal Ordinance No. 2001-534 in which the Municipal Government may adjust, amend or improve the percentage sharing through the passage of an ordinance;

WHEREAS, the creation of a PHILHEALTH Capitation Fund is necessary for the attainment of the purpose and objectives of the indigent program aimed at "Setting into motion a Meaningful Health Care Financing and Delivery Mechanisms Anchored on Local Government";

NOW THEREFORE, on motion of Hon. Samuel F. Balantac, duly seconded by Hon. Faustino H. Valdez, Jr., be it

RESOLVED, as it is hereby resolved to supplement Municipal Ordinance No. 2001-534 of the Municipality of Solsona for the utilization of the 20% administrative cost from the PHILHEALTH Capitation Fund ensuing from the proceeds of the Outpatient Consultation and Diagnostic Benefit Package provided by the Philippine Health Insurance Corporation (PHILHEALTH);

RESOLVED FURTHER, that the utilization of the 20% Capitation Fund which shall be charged to the PHILHEALTH Capitation Fund (PCF) shall be distributed as follows: 50% shall accrue to the Municipal Health Officer, 45% shall be divided among other RHU Staff involved in the provision of OPB Services and 5% shall be utilized for the procurement of additional laboratory apparatus and equipment;


RESOLVED FINALLY, to furnish copies of this Ordinance to all agencies concerned for their information;
