MUNICIPAL ORDINANCE NO. 2004-539

AN ORDINANCE REGULATING THE PREPARATION AND SALE OF MEAT IN SOLSONA, ILOCOS NORTE AND PROVIDING PENALTIES IN VIOLATION THEREOF.

WHEREAS, pursuant to Rule XVII, Art. 100, No. IV of RA 7160, the Sangguniang Bayan has the power to regulate the preparation and sale of meat through the enactment of an Ordinance for the general welfare of the Municipality and its inhabitants;

WHEREAS, due to the low of supply of hogs and cattle in the municipality, the unscrupulous businessmen take the opportunity to just increase the price of meat without the legal procedure to be followed which is detrimental to the producers and the consuming public;

WHEREAS, in order to protect both the businessmen, consumers and the producers, this August Body thought to enact this measure;

WHEREFORE, on motion of Hon. Bartolome Q. Asuncion duly seconded by Hon. Bob G. Sacro, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - the sale of meat in Solsona, Ilocos Norte is hereby regulated;

Section 2 - no person or persons shall be authorized to increase the sale of meat without the authority of the Sangguniang Bayan;

Section 3 - any person or persons who shall violate this act shall be fined of P1,500.00 for the first offense, P2,000.00 for the second offense and cancellation of business permit and/or both fine and imprisonment upon the discretion of the court for the third offense;

Section 4 - this Ordinance shall take effect upon its approval;


Copies of this Municipal Ordinance be furnished the Sangguniang Panlalawigan, Laoag City and all others concerned for their information and consideration;


