**AN ORDINANCE SUPPLEMENTING ARTICLE B, SECTION 148 OF  
MUNICIPAL ORDINANCE NO. 2001-529, OTHERWISE KNOWN AS THE  
REVISED REVENUE CODE OF THE MUNICIPALITY OF SOLSONA,  
ILOCOS NORTE.**


