MUNICIPAL ORDINANCE NO. 2004-541

AN ORDINANCE REQUIRING ALL BUSINESS ESTABLISHMENTS OPERATING IN AND WITHIN THE MUNICIPALITY OF SOLSONA TO SECURE A BUSINESS PLATE NUMBER AND STICKER FROM THE OFFICE OF THE MUNICIPAL MAYOR AND PROVIDING PENALTIES IN VIOLATION THEREOF.

WHEREAS, non-registration and colorum operation of business establishments has always been a chronic concern of the municipal government;

WHEREAS, such non-registration and colorum operations deprive the municipal government of much-needed revenues;

WHEREAS, to aid the municipal government curtail such practices and thereby increase its revenues derived from local sources;

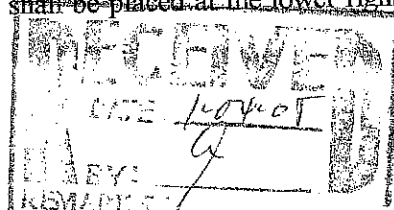
WHEREFORE, on motion of Hon. Jonathan L. de Lara, duly seconded by Hon. Ismael L. Agulay and Hon. Gervacio B. Vicente, be it

ORDAINED, by the Sangguniang Bayan of the Municipality of Solsona, that:

Section 1 - BUSINESS PLATE NUMBER. All business establishments operating in and within the jurisdiction of this municipality shall be required to secure a business plate number for every distinct line of business; PROVIDED, that the same shall be displayed in a conspicuous place within the business establishment, in full view of the public;

Such business plate number shall be secured only once by the owner/proprietor/operator of the business establishment at the start of operation; PROVIDED FURTHER, that businesses in operation at the approval of this Ordinance shall secure the same at the start of its effectivity or upon renewal of their permit to operate;

Section 2 - BUSINESS STICKER. A business sticker shall also be issued to business owners, which sticker shall be an indication that an establishment is duly authorized to engage in business during the year; PROVIDED, that the same shall be placed at the lower right hand corner of the business plate number;



Section 3 - ISSUANCE OF BUSINESS PLATE NUMBER AND STICKER. The business plate number and sticker shall be issued by the Office of the Municipal Mayor upon payment of TWO HUNDRED FIFTY PESOS (P250.00) for the business plate number, and FIFTY PESOS (P50.00) for the sticker and after the approval of the Mayor's Permit To Engage In Business;

Section 4 - PAYMENT OF FEES. The fees therefore shall be in addition to existing fees currently prescribed for business and shall be collected by the Municipal Treasurer or his duly authorized representative upon approval of the application to operate business;

Section 5 - PENALTY. Non-posting of business plate number and sticker shall be fined in the amount of ONE THOUSAND PESOS (P1,000.00) per business plate number and FIVE HUNDRED PESOS (P500.00) for the sticker;


Section 6 - EFFECTIVITY. This Ordinance shall take effect on the first working day of the year following its approval and after its posting in three (3) conspicuous places and publication for three (3) consecutive weeks in a local newspaper of general circulation;




