

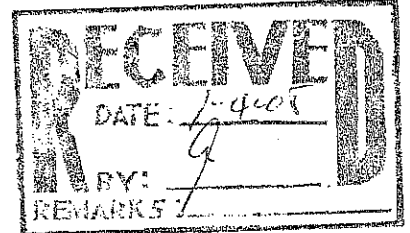

MUNICIPAL ORDINANCE NO. 2004-543

**AN ORDINANCE SUPPLEMENTING ARTICLE D. ASSESSOR'S AND  
TREASURER'S FEES SECTION 155 (IMPOSITION OF FEES) OF MUNICIPAL  
ORDINANCE NO. 2001-529 OTHERWISE KNOWN AS THE REVISED REVENUE  
CODE OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE.**

WHEREAS, pursuant to the provision of the Local Government Code of 1991, Article 122. Local Taxing Authority, the Sangguniang Bayan has the power to impose tax, fee or charge or to generate revenues;

NOW THEREFORE, on motion of Hon. Gervacio B. Vicente duly seconded by Hon. Bob G. Sacro, be it

ORDAINED, by the Sangguniang Bayan in session, that:

Section 1 - Section 155 (Imposition of Fees) of Municipal Ordinance No. 2001-529, otherwise known as the Revised Revenue Code of the Municipality of Solsona, Ilocos Norte is hereby supplemented with the added alphabet from E to M, to wit:

e. Identification/inspection of properties (declared/undeclared)	P 50.00
f. Re-classification	50.00
g. Correction of every erroneously declared owner	50.00
h. Vicinity Map	100.00
i. Conform Title (for every lot)	100.00
j. Building Assess (old and new)	200.00
k. Transfer Fee/Processing Fee	50.00
l. Research Service Fee	30.00
m. Partition of land (every lot)	100.00

Section 2 - This Ordinance shall take effect upon approval and after the lapse of 21 days posting in three (3) conspicuous places within the municipality;


Copies of this Municipal Ordinance be furnished the Sangguniang Panlalawigan, Laoag City and all others concerned for their information and consideration;

CARRIED UNANIMOUSLY, with the following votes:


