MUNICIPAL ORDINANCE NO. 2004-545

AN ORDINANCE REQUIRING ALL REAL PROPERTY OWNERS/ADMINISTRATORS OR THE DULY AUTHORIZED REPRESENTATIVES TO PREPARE AND FILE WITH THE OFFICE OF THE MUNICIPAL ASSESSOR A SWORN STATEMENT DECLARING THE TRUE VALUE OF THEIR PROPERTY STARTING JANUARY 2005 UP TO JUNE 30, 2005 AND EVERY THREE (3) YEARS THEREAFTER AND IMPOSING PENALTIES IN VIOLATION THEREOF.

WHEREAS, pursuant to Section 202 of RA 7160, owners/administrators of real properties are mandated to file a sworn statement declaring the true value of their property once in every three (3) years;

WHEREAS, the legislative body of Solsona recognizes the need to utilize fully its income sources in order to augment the meager income of the Local Government Unit;

NOW THEREFORE, on motion Hon. Gervacio B. Vicente duly seconded by Hon. Ismael L. Agulay, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - all real property owners/administrators or the duly authorized representatives to prepare and file with the Office of the Municipal Assessor a sworn statement declaring the true value of their property starting January 2005 to June 30, 2005 and every three (3) years thereafter is hereby required;

Section 2 - a penalty of the amount of not less than ONE THOUSAND PESOS (P1,000.00) but not more than TWO THOUSAND FIVE HUNDRED PESOS (P2,500.00) shall be imposed to owner/administrator of real property who do not comply accordingly;

Section 3 - this Municipal Ordinance shall take effect on the first working day of January, 2005 and after the lapse of 21 days posting in three (3) conspicuous public places and to be published in a newspaper of local circulation for three (3) successive weeks;


Copies of this Municipal Ordinance be furnished the Sangguniang Panlalawigan, Laoag City and all others concerned for their review and consideration;


