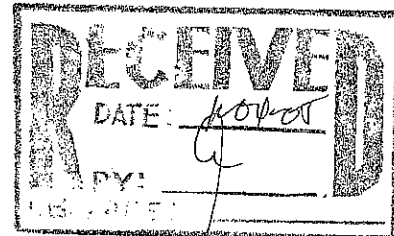

MUNICIPAL ORDINANCE NO. 2004-546

AN ORDINANCE SUPPLEMENTING ARTICLE F. FRANCHISE AND OTHER FEES ON TRICYCLE OPERATION, SECTION 92. (IMPOSITION OF FEE) OF MUNICIPAL ORDINANCE NO. 2001-529, OTHERWISE KNOWN AS THE REVISED REVENUE CODE OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE.

WHEREAS, pursuant to Article 100. (3) (VI) the Sangguniang Bayan, subject to the guidelines prescribed by the Department of Transportation and communications, is empowered to regulate the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction of the municipality and the Sangguniang Bayan is the authorized municipal franchising and regulatory body with respect to the operation of tricycle units for hire;

WHEREAS, non-registration and unofficial operation of tricycles for hire has always been a chronic problem of the municipal government;

WHEREAS, all motorized tricycle for hire operating within the jurisdiction of the Municipality of Solsona with undocumented existing side car number shall surrender and register the same for its verification and authentication of their permanent side car number upon application of their franchise;

WHEREFORE, on motion of Hon. Bob G. Sacro, duly seconded by Hon. Ismael L. Agulay, be it:

ORDAINED, by the Sangguniang Bayan in session Solsona, Ilocos Norte, that:

Section 1 - Article F (Franchise and Other Fees on Tricycle Operation) Section 92. (Imposition of Fee) of Municipal Ordinance No. 2001-529, otherwise known as the Revised Revenue Code is hereby supplemented with the addition of Section 92-G and H, which will read as follows:

“Section 92-G - Fee for the issuance of permanent side car number - All operators/drivers are required to secure sidecar number in the Office of the Sangguniang Bayan upon approval of his/her application for franchise to operate motorized tricycle for hire operating within the jurisdiction of the municipality of Solsona upon payment the amount of P150.00 per unit to the Municipal Treasurer or her duly authorized representative;

Section 92-H - Business Identification Sticker - All motorized tricycle for hire are required to secure yearly business identification sticker in the amount of P50.00, which shall be issued upon approval of their Mayor's Permit to Operate Business;”

Section 2 - This Supplemental Ordinance shall take effect after the lapsed of twenty-one (21) days posting in at least three (3) conspicuous places and to be published in a newspaper of local circulation;


