**MUNICIPAL ORDINANCE NO. 2004-547**

AN ORDINANCE SUPPLEMENTING CHAPTER VII - TRAFFIC AND ORDER, ARTICLE B. REQUIRED ACCESSORIES OF MOTOR VEHICLES, SECTION 193 OF MUNICIPAL ORDINANCE NO. 2001-530, OTHERWISE KNOWN AS THE ADMINISTRATIVE CODE OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE.

WHEREAS, pursuant to Article 100. (3) (VI) the Sangguniang Bayan, subject to the guidelines prescribed by the Department of Transportation and communications, is empowered to regulate the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction of the municipality and the Sangguniang Bayan is the authorized municipal franchising and regulatory body with respect to the operation of tricycle units for hire;

WHEREAS, the presence of complete motorcycle accessories tends to provide convenience both for the riding public and drivers/operators;

WHEREAS, motorcycle with side car which commonly known as "TRICYCLE" is the common carrier catering transportation services in the municipality;

WHEREAS, the installation and provision of back ride guard and driver shed in all tricycles for hire will inevitably suppress possible accidents that may occur anytime;

WHEREFORE, on motion of Hon. Bob G. Sacro, duly seconded by Hon. Ismael L. Agulay, be it

ORDAINED, by the Sangguniang Bayan in session Solsona, Ilocos Norte, that:

Section 1 - Chapter VII - Traffic and Order, Article B. Required Accessories of Motor Vehicles, Section 193 of Municipal Ordinance No. 2001-530, otherwise known as the Administrative Code is hereby supplemented with the addition of Section 193-G, which will read as follows:

"Section 193-G - All Operators and/or drivers shall install driver shed and back ride guard to every motorized tricycle for hire operating within the Municipality of Solsona, Ilocos Norte;

Section 2 - This Supplemental Ordinance shall take effect after the lapsed of twenty-one (21) days posting in at least three (3) conspicuous places and to be published in a newspaper of local circulation;


Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City, the Municipal Treasurer, Solsona, Ilocos Norte and to all concerned, for their information and consideration;

CARRIED UNANIMOUSLY, with the following votes:


