MUNICIPAL ORDINANCE NO. 55

AN ORDINANCE PROHIBITING PUBLIC UTILITY TRICYCLE FROM
OPERATING WITHOUT COMPLYING THE NECESSARY REQUIREMENTS AS
PRESCRIBED BY LAW.

WHEREAS, there is a need to protect the rights of
tricycle owners and drivers who have satisfactorily completed
all the requirements needed to operate as prescribed by the
Land Transportation Office (LTO),

NOW THEREFORE, on motion of Hon. Refani and duly
seconded by Hon. Batara and Hon. Ganal; be it

ORDERED, by the Sangguniang Bayan of Solsona, Ilocos
Norte that:

Section 1 - any operator/driver who has not complied
with all the requirements be prohibited from operating until
after he has completed the said requirements as prescribed by
law; to wit:

- a. Registration to the LTO
- b. Franchise
- c. Driver's License - Professional
- d. 50k quarterly payment
- e. Municipal permit
- f. Sanitary Permit
- g. Barangay Clearance
- h. Police Clearance
- i. 50k clearance

Section 2 - Any tricycle caught operating without the
necessary requirements as prescribed by both National and
Local laws shall be subjected to a fine of not less than ONE
HUNDRED FIFTY PESOS (P150.00), but not more than TWO HUNDRED
PESOS (P200.00) or imprisonment of 3 months but not more than
6 months or both at the discretion of the court;

SECTION 3 - This ordinance shall take effect after
the lapse of TEN DAYS (10) from the day a copy of it is posted
in the municipal hall, public market and other conspicuous
places;

Voting on the foregoing Ordinance as follows:
