MUNICIPAL ORDINANCE NO. 2005-550

AN ORDINANCE AUTHORIZING THE MUNICIPAL TREASURER TO COLLECT TO VIOLATORS OF THE MEMORANDUM OF AGREEMENT BETWEEN THE MEAT VENDORS AND THE SANGGUNIANG BAYAN REPRESENTED BY THE VICE-MAYOR & PRESIDING OFFICER, HON. EDISON E. DE LARA, REGARDING THE SALE OF MEAT IN THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE

WHEREAS, pursuant to the pertinent provision of RA 7160, the Sangguniang Bayan is empowered to regulate the sale of meat within its jurisdiction;

WHEREAS, a Memorandum of Agreement was made and entered into by the Members of the Solsona Meat Vendors Association and the Sangguniang Bayan, represented by the Vice Mayor & Presiding Officer, Hon. Edison E. de Lara of Solsona, Ilocos Norte;

NOW THEREFORE, on motion of Hon. Gervacio B. Vicente, duly seconded by Hon. Bob G. Sacro, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - The Municipal Treasurer is hereby authorized to collect fines to violators of the Memorandum of Agreement between the Meat Vendors and the Sangguniang Bayan of Solsona, Ilocos Norte, represented by the Vice Mayor & Presiding Officer, Hon. Edison E. de Lara;

Section 2 - This Ordinance shall take effect upon its approval.


