MUNICIPAL ORDINANCE NO. 2005-551

AN ORDINANCE AMENDING SECTION II OF ORDINANCE NO. 2000-523, PARAGRAPH THREE UNDER THE TERMS AND CONDITIONS OF ORDINANCE GRANTING FRANCHISE TO OPERATE MOTORIZED TRICYCLE FOR HIRE WITHIN THE JURISDICTION OF THE MUNICIPALITY OF SOLSONA, INCREASING FARE RATES, FOR REGULAR PASSENGER, FROM P4.00 TO P7.00 FOR THE FIRST TWO (2) KMS. AND ADDITIONAL P1.00 FOR ALL WEATHER ROADS AND P1.50 FOR ROUGH ROADS PER SUCCEEDING KILOMETER THEREAFTER; FOR STUDENTS P6.50 FOR THE FIRST TWO KMS. AND P0.75 PER SUCCEEDING KM. AND FOR SENIOR CITIZENS, P5.50 FOR THE FIRST TWO KMS. AND P0.80 PER SUCCEEDING KM., THEREAFTER.

WHEREAS, pursuant to Section 94, Administrative Provisions of Art. F - Franchise and other fees on tricycle operation of the Revised Revenue Code of Solsona, Ilocos Norte, the Sangguniang Bayan shall issue, amend, revise, renew, suspend or cancel MTOP and prescribe the appropriate terms and conditions therefore, determine, fix, prescribe or periodically adjust fares or rates for the service provided in a zone after public hearing; fix impose and collect and periodically renew and adjust but not oftener than once every three (3) years, reasonable fees and other related charges in the regulation of tricycle for hire;

WHEREAS, due to the unending increase of price of oil and spare parts, the STODA, requested an increase of fare rates to meet the present living condition;

NOW THEREFORE, on motion of Hon. Bob G. Sacro, duly seconded by Hon. Cresencio M. Vilorio, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - Section II of Municipal Ordinance No. 2000-523 on Paragraph three under the terms and conditions of Ordinance granting franchise to operate motorized tricycle for hire within the jurisdiction of the municipality of Solsona, is hereby amended, increasing fare rates for regular passenger, from P4.00 to P7.00 for the first two (2) kms. and additional P1.00 for all weather roads and P1.50 for rough roads per succeeding kilometer thereafter; for students P6.50 for the first two kms. and P0.75 per succeeding km. and for senior citizens, P5.50 for the first two kms. and P0.80 per succeeding km., thereafter;

Section 2 - this Municipal Ordinance shall take effect immediately upon approval and after the lapse of 21 days posting in three (3) conspicuous public places;


Copies of this Municipal Ordinance be furnished the Sangguniang Panlalawigan, Laoag City and all others concerned for their review and consideration;
