MUNICIPAL ORDINANCE NO. 2005-553

AN ORDINANCE IMPOSING FEES IN THE SALE OF BID DOCUMENTS AND OTHER CHARGES PURSUANT TO THE PROVISIONS OF BUDGET CIRCULAR NO. 2004-5, DATED MARCH 23, 2004 ISSUED BY THE DBM AND PROVIDING HONORARIA TO BAC MEMBERS AUTHORIZED UNDER SECTION 15 OF RA 9184, OTHERWISE KNOWN AS THE GOVERNMENT PROCUREMENT REFORM ACT.

WHEREAS, RA 9184, otherwise known as the Government Procurement Reform Act, authorized the members of the Bids and Awards Committee (BAC) to receive Honoraria to an amount not to exceed 25% of their respective basic monthly salary, thereby authorizing the DBM to promulgate the necessary guidelines, related thereto;

WHEREAS, the Sangguniang Bayan is empowered to enact Ordinance imposing reasonable fees pursuant to the provision of Budget Circular No. 2004-05, dated March 23, 2004;


NOW THEREFORE, on motion of Hon. Gervacio B. Vicente, duly seconded by Hon. Bob G. Sacro, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1. Imposition of Fees: There is hereby levied fees prescribed herein pursuant to Section 15 of RA 9184 and No. 5.0 of Budget Circular No. 2004-5, as follows:

- 1.1 Sale of Bid Documents - If the Approved Budget of the Contract (ABC) is:

10,000.00 and below	-	P 50.00
Above 10,000.00	-	1/2 of 1%
- 1.2 Annual Registration Fee in the Municipal Contractor or Supplier Registry Book - P300.00
- 1.3 Secretaries Fee per copy of the minutes of bid openings, BAC Resolutions and other BAC documents - P50.00/page
- 1.4 Protest Fee - 5% of the Approved Budget of the Contract
- 1.5 Liquidated Damages - The Municipal Engineer is hereby authorized to declare and compute for the liquidated damages of contractors per existing laws, rules and regulations;
- 1.6 Proceeds from bid/performance security forfeiture - Upon reasonable cause as determined by majority of the members of the BAC, the bid/performance security can be forfeited;



Section 2 - Time and Manner of Payment - The above-mentioned fees shall be paid to the Municipal Treasurer or her authorized representative upon filing or securing documents to the BAC Technical Working Group (TWG);

Section 3 - Sharing of Collections:

50% shall accrue to the General Fund

50% shall be treated as trust fund intended for Honoraria of the BAC and TWG members and for other operating and incidental expenses

Section 4 - This Ordinance shall take effect immediately upon approval and posting in at least three (3) conspicuous public places;


Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City and all others concerned, for their information and consideration;

CARRIED UNANIMOUSLY, with the following votes:


