MUNICIPAL ORDINANCE NO. 2005-554

AN ORDINANCE SUPPLEMENTING SECTION 29. ACTS PROHIBITED AND PUNISHABLE OF MUNICIPAL ORDINANCE NO. 2000-526, CHAPTER III LAND RESOURCES INSERTING SUB ITEM A-1, TO READ, PROHIBITING THE USE OF PREMIUM SPECIES TREES BY FURNITURE SHOPS AND LUMBER YARDS WITHIN THE JURISDICTION OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE.

WHEREAS, one of the top perennial problem of the Municipality is the illegal cutting of trees in the mountain of its jurisdiction;

WHEREAS, it has been observed that furniture shops are using the Premium Species Trees especially narra in the making of office tables, chairs, cabinet, dividers and others;

NOW THEREFORE, on motion of Hon. Bob G. Sacro, duly seconded by Hon. Bartolome Q. Asuncion and Hon. Gervacio B. Vicente, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that

Section 1 - the insertion of Sub-Item A-1 of Section 29 (Acts Prohibited and Punishable) of Municipal Ordinance No. 2000-526, otherwise known as the Environment Code of the Municipality, Chapter III, to read, Prohibiting the use of Premium Species Trees by the furniture shops and lumber yards within the jurisdiction of the Municipality of Solsona, Ilocos Norte, is hereby supplemented;

Section 2 - this Municipal Ordinance shall take effect immediately upon approval and after the lapse of 21 days posting in three (3) conspicuous public places;

Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City and all others concerned, for their information and consideration;

CARRIED UNANIMOUSLY, with the following votes:




