**MUNICIPAL ORDINANCE NO. 2005-555**

**AN ORDINANCE SUPPLEMENTING THE REVISED REVENUE CODE OF 2001, UNDER ART. G. FEES FOR SEALING, LICENSING AND CALIBRATION OF WEIGHTS AND REGULATIONS THEREOF, SECTION 210. IMPOSITION OF FEES, INSERTING SUB-ITEM B-2. COST OF WEIGHING SCALE STICKER IN THE AMOUNT OF TWENTY PESOS (P20.00) PER STICKER.**

WHEREAS, calibration of weighing scale are calibrated once every six months in order to protect the buying public as mandated under Section 210 (B) of Municipal Ordinance No. 2001-529;

WHEREAS, there is a need to control the said calibration of weighing scale by having a sticker bearing the date of calibration, control number, expiration and the name of the calibrating officer in order to ensure the enforcement of the above provision of law;

NOW THEREFORE, on motion of Hon. Lucky S. Sanchez, duly seconded by Hon. Gervacio B. Vicente and Hon. Bob G. Sacro, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - the Revised Revenue Code of 2001 under Article G. Fees for Sealing, Licensing and Calibration of Weights and Regulations Thereof, Section 210. Imposition of Fees, inserting Sub-Item B-2. Cost of Weighing Scale Sticker in the amount of TWENTY PESOS (P20.00) per sticker, is hereby supplemented;

Section 2 - Time of Payment. The fee herein collected shall be paid to the Municipal Treasurer or her duly authorized representative upon calibration of said weighing scale;

Section 3 - this Municipal Ordinance shall take effect immediately upon approval and after the lapse of 21 days posting in three (3) conspicuous public places;


Copies of this Municipal Ordinance be furnished the Sangguniang Panlalawigan, Laoag City and all others concerned for their information;


