

MUNICIPAL ORDINANCE NO. 2006-557

AN ORDINANCE DESIGNATING THE MUNICIPAL TOWN PLAZA AND MUNICIPAL PUBLIC THEATER AS FREEDOM PARKS OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE IN ACCORDANCE WITH SECTION 16, BATAS PAMBANSA BLG. 880, OTHERWISE KNOWN AS THE PUBLIC ASSEMBLY ACT OF 1985.

WHEREAS, in compliance with the Supreme Court's specific instruction, pursuant to Memorandum Circular No. 2006-42, dated May 4, 2006, the Sangguniang Bayan is mandated to enact an Ordinance designating Freedom Parks within the municipality;

WHEREAS, freedom parks shall be used to hold an assemblies and rallies as defined in BP Blg. 880, and shall be exempted from the requirement of a prior permit for their use from the Office of the Mayor, however as per Supreme Court pronouncement, organizers of assemblies shall send written notices to the Philippine National Police and the Mayor's Office to allow proper coordination and to ensure orderly activities;

NOW THEREFORE, on motion of Hon. Gervacio B. Vicente duly seconded by Hon. Samuel F. Balantac, be it

ORDAINED, by the Sangguniang Bayan in session, that:

Section 1 - the Municipal Town Plaza and the Municipal Public Theater is hereby designated as Freedom Parks of the Municipality of Solsona, Ilocos Norte, in accordance with Section 16, Batas Pambansa Blg. 880, otherwise known as the Public Assembly Act of 1985;

Section 2 - this Ordinance shall take effect immediately upon its approval;


Copies of this Municipal Ordinance be furnished the Sangguniang Panlalawigan, Ilocos Norte and the Department of the Interior and Local Government, Ilocos Norte, for their information;




