

MUNICIPAL ORDINANCE NO. 2007-559

AN ORDINANCE AUTHORIZING THE DEPUTIZED BUILDING OFFICIAL AND STAFF OF THE MUNICIPAL GOVERNMENT OF SOLSONA, ILOCOS NORTE TO COLLECT MONTHLY HONORARIA OUT FROM THE TWENTY (20%) PERCENT ON THE TOTAL COLLECTION OF BUILDING PERMIT FEES AND CHARGES, EFFECTIVE JANUARY 2, 2007.

WHEREAS, the provisions under Sections 208 and 210 of the National Building Code of the Philippines, authorizes the Deputized Building Official to retain not more than twenty (20%) percent of his collection for the operational expenses and sheriff's and payment of prior year's not adequately funded subject to existing rules and regulations;

WHEREAS, the Office of the Building Official are responsible for the enforcement and implementation of the requirements of the National Building Code of the Philippines as well as the implementing rules issued thereof in the issuance of building permit, which is an additional duty and function to the Office they are officially managing in the municipal level;


WHEREAS, the imposition of monthly honorarium is acceptable and permissible under the law, however, it should be computed based on the collection of building permit fees and charges;

NOW THEREFORE, on motion of Hon. Ismael L. Agulay, unanimously seconded by all the members present, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte in session, that:

Section 1 - the Deputized Building Official and Staff of the municipal government of Solsona, Ilocos Norte is hereby authorized to collect monthly honoraria out from the twenty (20%) percent of the total collection of building permit fees and charges, retroactive January 02, 2007;

Section 2 - the manner of collection by the Building Official and Staff shall be regulated and governed by existing rules and regulations related to the imposition of honoraria;

Section 3 - this Municipal Ordinance shall take effect immediately upon its approval;


