MUNICIPAL ORDINANCE NO. 2007-563

AN ORDINANCE ESTABLISHING AN AWARDS SYSTEM FOR THE THREE-TERMER ELECTIVE BARANGAY OFFICIALS OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE.

WHEREAS, this system is giving motivation to dedicated officials and employees to improve their performance;

WHEREAS, there is a need to establish an Awards system to the three-termer elective barangay officials of the municipality to fittingly honor and appreciate their hard work and dedication to the public service;

NOW THEREFORE, upon motion of Hon. Jose a. Martin, unanimously seconded by all the members present, be it

ORDAINED by the Sangguniang Bayan of the Municipality of Solsona, Ilocos Norte that:

- Section 1- Title-** This ordinance shall be known as "An ordinance establishing an Awards System for the three-termer Elective Barangay Officials of the Municipality of Solsona, Ilocos Norte.
- Section 2- Scope and Coverage-** This ordinance shall govern the giving of awards to all elective Barangay Officials who have completed their three (3) consecutive terms in the same position.
- Section 3- Recognition Awards -** All barangay officials who have completed the three (3) consecutive term for the same position shall be given a Certificate of Recognition to be given by the Municipal Mayor.

Section 4- Awarding- The Certificate of Recognition shall be given in an appropriate ceremony scheduled at the end of the term of recipient three-termer elective barangay officials.

Section 5- Effectivity Clause- This ordinance shall take effect immediately after the prescribed posting requirements and shall apply to all three-termer elective barangay officials whose term ends on twelve o'clock noon of November 30, 2007 and every barangay election thereafter.

Copies of this Municipal Ordinance be furnished the Sangguniang Panlalawigan, Laoag City and all agencies concerned for their information and appropriate action;
