**MUNICIPAL ORDINANCE NO. 2007-564**

**AN ORDINANCE REGULATING THE OPERATION OF VIDEOKE MACHINES WITHIN THE JURISDICTION OF SOLSONA, ILOCOS NORTE AND PROVIDING PENALTIES IN VIOLATION THEREOF.**

WHEREAS, Section 447 of RA 7160, otherwise known as the Local Government Code of 1991 authorizes the Sangguniang Bayan to enact measures intended to promote the welfare of all the inhabitants;

WHEREAS, overnight operation of videoke machines creating loud sound, clatters and other noises created by costumers, attendees or partakers generate and cause nuisance, disturbance during operation and the involvement of young individuals that will partly disturb or affect their schooling;

NOW THEREFORE, on motion of Hon. Dixie C. Miguel, unanimously seconded by all the members present, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, duly assembled in session, that:

Section 1 – The operation of Videoke Machines within the territorial jurisdiction of Solsona, Ilocos Norte, is hereby regulated;

Section 2 – Owners and/or operators of videoke machines shall not be allowed to operate within a fifty (50) meter radius from the vicinity of public and private schools, Churches and the Municipal Hall;

Section 3 – Operation of videoke machines shall tuned down the volume at 9:00 P.M. and shall be totally closed at 11:00 P.M.; Special occasions like birthdays, anniversaries, weddings, get-together-parties, programs, meetings and other similar gatherings shall be exempted on the closure of 11:00 P.M., as imposed, however they will tune down the videoke machines at 9:00 P.M.;

Section 4 - Any individual group or party and operator or owner involved directly or indirectly in the operation of videoke machines that violate the provisions of this Ordinance shall be fined based on the following schedule of penalties:

- 1<sup>st</sup> Offense - a fine of FIVE HUNDRED PESOS (P500.00)
- 2<sup>nd</sup> Offense - a fine of ONE THOUSAND PESOS (P1,000.00)
- 3<sup>rd</sup> Offense - a fine of TWO THOUSAND FIVE HUNDRED PESOS (P2,500.00) or imprisonment of one (1) month or both fine and imprisonment upon the discretion of the Court.

Section 5 - This Ordinance shall take effect after twenty-one (21) days from the date a copy thereof is posted in the Municipal Hall and in at least two (2) conspicuous places and after complying with all the requirements setforth in the Local Government Code of 1991;

Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City for their information and appropriate action;




