**MUNICIPAL ORDINANCE NO. 2008 – 565**

**AN ORDINANCE NAMING THE NEWLY CONSTRUCTED FUNCTION HALL OF THE MUNICIPAL BUILDING OF SOLSONA, ILOCOS NORTE TO "EULOGIO BARIA LUZ FUNCTION HALL."**

WHEREAS, Section 13 of the Local Government Code of 1991 provides among others the Naming of Local Government Units and Public Places;

WHEREAS, paragraph c of said section 13 of the Local Government Code of 1991 grant the power of the Sanggunians of municipalities, in consultation with the National Historical Institute, to name or change the name of public places within their territorial jurisdiction;

WHEREAS, the National Historical Institute interposes no objection to the request of the Sangguniang Bayan of Solsona, Ilocos Norte to name the newly constructed Function Hall of the municipal building to "EULOGIO B. LUZ FUNCTION HALL" in commemoration of the late Eulogio B. Luz, a Retired Public School Teacher and former Municipal Councilor of Solsona, Ilocos Norte, said request being embodied in Resolution No. 2008-004 unanimously approved by the Sangguniang Bayan of the municipality;

NOW THEREFORE, upon motion of Hon. Bob G. Sacro, with the unanimous accord of all the members present, BE IT ORDAINED, that

Section 1- The newly constructed Function Hall of the municipal building of Solsona, Ilocos Norte be named as "EULOGIO BARIA LUZ FUNCTION HALL" to commemorate one of the prominent sons of the municipality, the late Hon. Eulogio B. Luz, a former Public School Teacher and a Former Municipal Councilor;

Section 2- This municipal ordinance shall be made to effect the naming of the Function Hall of the Municipal Building to "EULOGIO BARIA LUZ FUNCTION HALL" after the completion of the posting requirement in the bulletin board of the municipality and on two (2) other conspicuous places in the municipality of Solsona, Ilocos Norte;


