MUNICIPAL ORDINANCE NO. 2008 - 566

AN ORDINANCE CREATING AN AD HOC COMMITTEE OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE AND TECHNICAL WORKING TEAMS TO TAKE CHARGE OF ALL MATTERS PERTAINING TO BOUNDARY DISPUTES WITH OTHER LOCAL GOVERNMENT UNITS.

WHEREAS, there are possible boundary disputes of the municipality with the adjoining municipalities of Nueva Era, Dingras, Piddig and Carasi, all of the province of Ilocos Norte;

WHEREAS, it is a policy of the municipality to settle these boundary disputes amicably to maintain the goodwill and friendly ties with our neighbor local government units;

WHEREAS, there is an imperative need of creating an Ad Hoc Committee of the Municipality of Solsona, Ilocos Norte and Technical Working Teams to take charge of all matters pertaining to boundary disputes involving our municipality with our neighbor municipalities;


NOW THEREFORE, upon motion of Hon. Jose A. Martin unanimously seconded by all the members present, be it
