

MUNICIPAL ORDINANCE NO. 2008 - 570

MUNICIPAL ORDINANCE NAMING THE NEWLY CONSTRUCTED CIVIC CENTER OF SOLSONA, ILOCOS NORTE INTO FEDERICO F. DE LARA CIVIC CENTER.

WHEREAS, the municipality of Solsona, Ilocos Norte enjoy that singular distinction of having constructed a modern civic center in terms of its structural design, which serve as a suitable venue for big cultural, civic and sports activities of the municipality;

WHEREAS, up to this time, our civic center bears no name yet even if the Sangguniang Bayan is empowered by law to name or change the names of any public place or building owned by the municipal government due to the critical issue of selecting the deserving honoree whom this edifice will be named after;

WHEREAS, the Sangguniang Bayan have conducted several public consultations to get the popular opinion of the public as to who would be the most appropriate and deserving personages of the municipality who have exceptional contribution to the community in terms of historical value and significance;

WHEREAS, in series of public consultation conducted for this purpose, the name of the late Federico F. de Lara, a former Municipal Secretary of the municipality during the years 1952 to 1959 have surfaced to be the most deserving and worthy of giving the honor of naming our civic center in his name;

NOW THEREFORE on motion of Hon. Jose A. Martin with the unanimous accord of all members present, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1. The newly constructed civic center of the municipality of Solsona, Ilocos Norte be named as "FEDERICO F. DE LARA CIVIC CENTER";

Section 2. All community affairs and other significant events of the municipality shall be held in this civic center except when the organizers of the affairs/events so specify that these be held in other venues;

Section 3. This Municipal Ordinance shall take effect upon its approval and compliance of the posting and public hearing requirements;

Copies of this Municipal Ordinance be forwarded to the Sangguniang Panlalawigan, Provincial Capitol, Laoag City for their review and other offices and authorities concern for their information, favorable and appropriate action.
