**MUNICIPAL ORDINANCE NO. 2008-573**

**AN ORDINANCE CREATING THE POSITION OF LOCAL LEGISLATIVE STAFF OFFICER IV IN THE OFFICE OF THE SANGGUNIANG BAYAN OF SOLSONA, ILOCOS NORTE.**

**WHEREAS**, the Civil Service Commission has promulgated Resolution No. 071813, dated September 10, 2007, declaring some positions in the Office of the Vice Governor/Vice Mayor and Sangguniang Bayan Members of the Local Government Unit as primarily confidential including but not limited to the position of Local Legislative Staff Officer IV, SG 19;

**WHEREAS**, Civil Service Commission Memorandum Circular No. 22, series of 2007, dated November 5, 2007 was issued by the Civil Service Commission, defining the policies and guidelines on Primarily Confidential Positions in the Local Government Unit;

**WHEREAS**, it is the desire of the Sangguniang Bayan of Solsona, Ilocos Norte to improve the level of performance of its legislative functions by strengthening the legislative staff thru the creation of the position of Local Legislative Staff Officer IV, in the Office of the Sangguniang Bayan of Solsona, Ilocos Norte;

**WHEREAS**, the Municipal Finance Committee of Solsona, Ilocos Norte, certified that the Personal Services Limitation for Calendar Year 2008 has not exceeded and that there is an available funds for the said position;

**NOW THEREFORE**, on motion of Hon. Ismael L. Agulay, duly seconded by Hon. Jovencio M. Pascua, Hon. Andresito A. Luis and Hon. Christopher A. Curameng, Jr., be it

**ORDAINED**, by the Sangguniang Bayan of Solsona, Ilocos Norte: that

**Section 1** – the position of **Local Legislative Staff Officer IV**, SG 19 (Co-Terminus) in the Office of the Sangguniang Bayan of Solsona, Ilocos Norte, is hereby created;

**Section 2** – this Ordinance shall take effect immediately upon approval;
