MUNICIPAL ORDINANCE NO. 2009-575

AN ORDINANCE CREATING THE POSITION OF LICENSE OFFICER I IN THE OFFICE OF THE MUNICIPAL MAYOR OF SOLSONA, ILOCOS NORTE.

WHEREAS, Section 447 (VIII) of the Local Government Code provides that the Sangguniang Bayan shall determine the positions and the salaries, allowances and other emoluments and benefits of the Officials and Employees of the Local Government Unit;

WHEREAS, the Sangguniang Bayan is likewise empowered to create any position in the LGU based on the priority needs of the municipality as identified by the Local Chief Executive provided all the mandatory positions have been created, the salary standardization has been fully implemented and the budgetary limitations on Personal Services (PS) expenditures are not exceeded as provided in Sec. 325 of the Local Government Code;

WHEREAS, the position of a Licensing Officer I, with a Salary Grade 11 of the Office of the Municipal Mayor has been certified as urgent and very necessary by the Local Chief Executive to effectively address the priority developmental plans, programs and objectives of his Office;

NOW THEREFORE, upon motion of Hon. Jose A. Martin with the unanimous accord of all the members present, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that

Section 1 – the position of Licensing Officer I with Salary Grade 11 in the Office of the Municipal Mayor of Solsona, Ilocos Norte, is hereby created;

Section 2 – the Sangguniang Bayan shall provide thru an Appropriation Ordinance the adequate funding requirements for the basic salary, including the associated compensation attached to the position such as allowances, RATA if entitled thereto, year-end benefits and others as provided by law;

Section 3 – This Ordinance shall take effect immediately upon approval;

Copies of this Ordinance be furnished to the Sangguniang Panlalawigan, Province of Ilocos Norte for its review and consideration and Ms. Nieves T. Duldulao, Director II, CSC, Ilocos Norte Field Office, Laoag City, for her information;
