MUNICIPAL ORDINANCE NO. 2009-581

AN ORDINANCE RECOGNIZING THE FIRST NEWLY BORN BABY ON JANUARY 01, 2010 AT THE RURAL HEALTH UNIT OF SOLSONA, ILOCOS NORTE AS THE CENTENNIAL BABY OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE AND PROVIDING FUNDS THEREOF.

WHEREAS, pursuant to Proclamation No.1960, dated December 8, 2009 of Her Excellency President Gloria Macapagal Arroyo, 2010 has been declared as the Centennial Year of the Municipality of Solsona, Ilocos Norte;

WHEREAS, the Sangguniang Bayan of Solsona, Ilocos Norte adopted the Centennial Year and recognizing the first newly born baby as the Centennial Baby shall be a part of the celebration of the Solsona Centennial Anniversary;

NOW THEREFORE, on motion of Hon. Dixie C. Miguel, duly seconded by all members present, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte in session assembled that:

Section 1 – This Ordinance shall be known as the Solsona Centennial Baby Ordinance;

Section 2 – The Local Chief Executive shall be given the authority to create the Solsona Centennial Baby Committee. The committee shall consists one (1) Chairman and three (3) members. The function of which shall be:

- a. To promulgate the rules, policies and guidelines in determining qualified centennial baby's awardee;
- b. To determine the awards and benefits to be given to qualified centennial baby awardee;
- c. To determine and select qualified centennial baby awardee;

Section 3 - Funds for the awards and benefits of the Solsona Centennial Baby Awardee shall be taken from the General Fund of Calendar Year 2010 of the Municipality of Solsona, Ilocos Norte;

Section 4 – Effectivity. This Ordinance shall take effect on January 1, 2009 during the celebration of the Solsona Centennial Anniversary;

Copies of this Municipal Ordinance shall be forwarded to the Sangguniang Panlalawigan, Provincial Capitol, Laoag City for their review and other offices and authorities concerned for their information and consideration;


