MUNICIPAL ORDINANCE NO. 2009-582

AN ORDINANCE AMENDING SECTION 4A.03 OF MUNICIPAL ORDINANCE NO. 2008-571, OTHERWISE KNOWN AS THE MARKET CODE OF SOLSONA, ILOCOS NORTE.

WHEREAS, the Sangguniang Bayan has enacted the Municipal Ordinance No. 2008-571, otherwise known as the Market Code of 2008 of the municipality;

WHEREAS, Section 4A.03.A. provided for the rental charges on stalls, booths and/or spaces within the market building;

WHEREAS, Section 4A.03.A(a) provided for the rental charges on stalls with booths constructed by the Municipal Government, per square meter or fraction thereof, per month;

WHEREAS, the rental charges provided in the aforesaid section when implemented will cause financial dislocation on the part of the stall lessees thus forcing them to increase the prices of their products and services which will be very disadvantageous to our constituents;

WHEREAS, there is a need to impose a more reasonable fees to help both the stall lessees and the public;

NOW THEREFORE, on motion of Hon. Andresito A. Luis duly seconded by all members present, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte in session duly assembled that:

SECTION 1. Section 4A.03 Imposition of Market Fees and Charges, A. Rental Charges on stalls with booths, within the market building of the Municipality of Solsona is hereby amended as follows:

CLASS A STALLS: Rentals: P45/square meter per month and fraction thereof. All stalls in the public market facing the national, provincial and municipal roads.

CLASS B STALLS: Rentals: P30/square meter per month and fraction thereof. All stalls inside the public market and all other stalls not classified as Class A.

Section 2. Separability Clause. If for any reason any part or provision is declared unconstitutional or invalid, other parts or provisions which are not affected thereby shall continue to be in full force and effect.

Section 3. Effectivity. This ordinance shall take effect upon approval and upon compliance of the existing rules of posting as provided by the Local Government Code of 1991.

Copies of this Municipal Ordinance shall be forwarded to the Sangguniang Panlalawigan, Provincial Capitol, Laoag City for their review and other offices and authorities concerned for their information, favorable and appropriate action.
