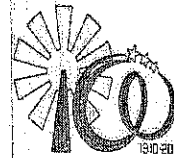

MUNICIPAL ORDINANCE NO. 2010-583

AN ORDINANCE ESTABLISHING THE MUNICIPAL PEOPLE'S MUSEUM OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE AND PROVIDING FUNDS FOR ITS OPERATION AND MAINTENANCE THEREOF.

WHEREAS, Year 2010 was declared as the Centennial Year of the municipality of Solsona, Ilocos Norte by virtue of Presidential Proclamation No.1960 dated December 8, 2009 issued by Her Excellency President Gloria Macapagal Arroyo;

WHEREAS, the municipality is celebrating its Centennial Foundation Anniversary for the whole month of January 2010 with a series of significant culturally and historically oriented programs, projects and activities;

WHEREAS, the municipality has constructed a Centennial Landmark and improvement of the old Public Theatre to house the proposed Municipal Museum of the municipality for the display of anthropologic, ethnographic, historic items, costumes and museum objects including fine arts and industries' items and objects to promote the rich and historical culture of the people of the municipality;

NOW THEREFORE, upon motion of Hon. Jose A. Martin, unanimously seconded by all the members present, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 – the Municipal Museum of the municipality which is hereby established shall be officially referred to as **“MUNICIPAL PEOPLE'S MUSEUM”** of the municipality of Solsona, Ilocos Norte;

Section 2 – Definition of Terms:

- Museum includes any collection of archaeological and ethnographical specimen, artifacts, pioneer relics, articles, documents and other things of historical, scientific purposes or to commemorate the occupation and development of the municipality and the structure or structure housing such collections;
- Museum objects includes specimen, artifacts documents and such items as may be deemed as historical in nature;
- Museum building means a building site or historic place used for a public museum;

Section 3 – Museum Administrator:

The Municipal Mayor shall designate a competent Official of the municipality on a concurrent capacity as Museum Administrator to oversee the operation, maintenance and development of the Municipal Museum;

Section 4 – The Sangguniang Bayan shall appropriate sufficient funds in its annual budget for the operation, maintenance and development of the Municipal Museum;

Section 5 – This Ordinance shall take effect immediately upon its approval and compliance of the posting and public hearing requirement as provided for in RA 7160;

Copies of this Municipal Ordinance shall be forwarded to the Sangguniang Panlalawigan, Provincial Capitol, Laoag City for their review and other offices and authorities concerned for their information, favorable and appropriate action;


