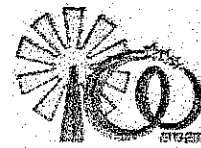

**MUNICIPAL ORDINANCE NO. 2010-585**

**AN ORDINANCE ABOLISHING THE VACANT POSITIONS OF ACCOUNTANT II, SG 15 IN THE OFFICE OF THE MUNICIPAL ACCOUNTANT, AGRICULTURAL TECHNOLOGIST I, SG 10 IN THE OFFICE OF THE MAYOR (MAO), LICENSE INSPECTOR II, SG 8 IN THE OFFICE OF THE MAYOR (LICENSING DIVISION), STATISTICIAN, SG 11 IN THE OFFICE OF THE MPDC AND LOCAL LEGISLATIVE STAFF OFFICER IV SG 19, OFFICE OF THE SANGGUNIANG BAYAN.**

WHEREAS, the Municipality of Solsona, Ilocos Norte was re-classified from a 4<sup>th</sup> class to a 3<sup>rd</sup> class municipality by virtue of Bureau of Local Government Finance Memorandum Circular No. 01-M(32-a)-08 dated July 22, 2009, thereby making the municipality to adjust its PS limitation from 55% to 45%;

WHEREAS, the Municipal Finance Committee recommends the abolition of some vacant positions of some offices which were always funded with appropriations in order not to exceed the allowable 45% Personal Services Limitation pursuant to Section 325 (a) of the Local Government Code of 1991;

WHEREAS, these positions have been vacant for such a long time, yet the offices concerned were able to run and operate smoothly without these vacant positions filled up;

WHEREAS, concerned offices issued certification of no objection on the abolition of the aforesaid positions;

NOW THEREFORE, upon motion of Hon. Marcelino M. Quitoras, Jr., duly seconded by Hon. Jovencio M. Pascua, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 – The vacant positions Accountant II SG 15 in the Office of the Municipal Accountant, Agricultural Technologist I, SG 10 in the Office of the Mayor (MAO), License Inspector II, SG 8 in the Office of the Mayor (Licensing Division), Statistician, SG 11 in the Office of the MPDC and Local Legislative Staff Officer IV SG 19, Office of the Sangguniang Bayan are hereby abolished;
