MUNICIPAL ORDINANCE NO. 59

AN ORDINANCE REGULATING COCKFIGHTING AND
COMMERCIAL BREEDING OF GAME COCKS WITHIN
THE JURISDICTION OF SOLSONA, ILOCOS NORTE.

WHEREAS, under the provisions of R.A. 7160, other-
wise known as the Local Government Code of 1991 in Article
Three, Section 447, Powers and Duties of the Sangguniang
Bayan Paragraph 3, Roman Numeral V, states any law to the
contrary notwithstanding authorize and license the estab-
lishment, operation and maintenance of cockpits and regu-
late cockfighting and commercial breeding of gamecocks;
Provided, that existing rights should not be prejudiced;

WHEREAS, there is no existing rights being enjoined
by the municipality prior to the enactment of this ordinance;

WHEREFORE, on motion of Hon. Henry A. Batara, duly
seconded by Hon. Jovencio M. Pascua and Hon. Agripino Estavillo,
be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos
Norte, that:

Section 1 - That cockfighting and commercial breed-
ing of gamecocks be regulated within the jurisdiction of
Solsona, Ilocos Norte;

Section 2 - That the Local Chief Executive is author-
ize to issue permits and license of cockpits;

Section 3 - The fees to be collected to the cockpits
owners are as follows:

Mayor's Permit	- ₱30.00
Sanitary Permit	- 10.00
Health Certificate	- 5.00
License	- 240.00
Governor's Permit	- 40.00
Gaffer's Fee	- 40.00

Section 4 - Cockfighting shall only be held and conduc-
ted outside the Poblacion of Solsona, Ilocos Norte in a cockpits
arena, located not less than 500 meters from any residential area
or public and religious buildings;

Section 5 - Cockfighting shall only be authorize and conducted on Wednesdays and Saturdays and any other days specified in the permit issued by the Local Government Unit from 12:00 noon to 8:00 P.M., the same day;

Section 6 - Maintenance of Peace and Order shall be directly under the responsibility of the Management in coordination with the Philippine National Police;

Section 7 - All Rules and Regulations governing the conduct of cockfighting in Solsona, Ilocos Norte should strictly followed;

Section 8 - This Ordinance shall take effect after the lapse of ten (10) days from the day a copy of it is posted in the Municipal Hall, Public Market and other conspicuous places and upon publication in a newspaper as required by law;

Voting on the foregoing Municipal Ordinance, as follows:

Infavor - Members: Batara, Teodoro, Vicente, Pascua, Ganal, Agulay, Estavillo, Refani, Edison de Lara and Jonathan de Lara;

Against - None.
