MUNICIPAL ORDINANCE NO. 2013 – 595

AN ORDINANCE ESTABLISHING THE TEN DISTRICTS OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE.

WHEREAS, the Sangguniang Bayan have adopted their respective District Assignments as provided for under Section 8 of the Internal Rules of Procedures of the 8th Sangguniang Bayan, of which every member is tasked to take charge of the programs, projects and activities of the barangay as well as to know and bring to the legislative body the needs and problems of their assigned districts;

WHEREAS, Section 8 of the IRP states that each member of the Sangguniang Bayan shall have district assignment consisting of two or more barangays which he/she represents for a period of six (6) months in any given time.

WHEREAS, with the mandate to provide efficient and effective delivery of basic services and facilities to the people, the establishment of the ten districts of the municipality is necessary to ensure that delivery of basic services is provided;

NOW THEREFORE, on motion of Hon. Edison E. De Lara, unanimously seconded by the members present, be it ;

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte in session assembled, that:

SECTION 1. The ten districts of the Municipality of Solsona is hereby established to wit:

- District 1 (Barangays Juan & Laureta)**
- District 2 (Barangays Santiago & Bagbago)**
- District 3 (Barangays Puttao & Nagpatpatan)**
- District 4 (Barangays Sta. Ana & Catangraran)**
- District 5 (Barangays Mariquet & Manalpac)**
- District 6 (Barangays Maananteng & Talugtog)**
- District 7 (Barangays Nalasin, Lipay & San Julian)**
- District 8 (Barangays Darasdas & Aguitap)**
- District 9 ((Barangays Bagbag, Barcelona & San Juan)**
- District 10 (Barangays Bubuos & Capurictan)**

SECTION 2. The ten districts shall be designated to the Sangguniang Bayan Members (including the Ex-Officio Members) at a manner the Sanggunian prefer. It may be through a draw lots, according to rank, etc.

SECTION 3. The reshuffling shall be held every after six (6) months as provided for under the IRP of the Sangguniang Bayan.

SECTION 4. EFFECTIVITY. This Ordinance shall take effect immediately after approval and after the completion of the required posting or publication.

Copies of this Municipal Ordinance shall be forwarded to the Sangguniang Panlalawigan, Provincial Capitol, Laoag City for their review and other offices and authorities concerned for their information and appropriate action;
