


MUNICIPAL ORDINANCE NO. 2013 – 596

AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2012-591, OTHERWISE KNOWN AS AN ORDINANCE CREATING THE PHILHEALTH CAPITATION FUND FROM THE PROCEEDS OF THE OUTPATIENT BENEFIT PACKAGE TO BE PROVIDED BY THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH) FOR LGU IDENTIFIED FAMILIES OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE THROUGH THE PARTIAL SUBSIDY SCHEME OF THE NATIONAL HEALTH INSURANCE PROGRAM (NHIP).

NOW THEREFORE, on motion of Hon. Edison E. De Lara, unanimously seconded by the members present, be it ;

Be it **ORDAINED** by the 8th Sangguniang Bayan of Solsona, Ilocos Norte in session assemble that,

SECTION 1. During the 22nd Outdoor and 71st Regular Session of the 8th Sangguniang Bayan on April 30, 2012, Municipal Ordinance No. 2012-591, "AN ORDINANCE CREATING A PHILHEALTH CAPITATION FUND FROM THE PROCEEDS OF THE OUTPATIENT BENEFIT PACKAGE TO BE PROVIDED BY THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH) FOR LGU IDENTIFIED FAMILIES OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE THROUGH THE PARTIAL SUBSIDY SCHEME OF THE NATIONAL HEALTH INSURANCE PROGRAM (NHIP)" has been enacted;



SECTION 2. Considering that there are provisions which need to be included under Section 1, particularly subtitle 2.3 thereof, the same shall be amended to read as follows:

SECTION 1.

2.3. EIGHTY PERCENT (80%) of the PCF is for operation cost and shall be divided as follows:

2.3.1 Minimum of forty percent (40%) for drugs and medicines listed in the Philippine Drug Formulary (to be dispensed at the facility) including drugs and medicines for Asthma, Age and pneumonia and

2.3.2 Maximum of forty percent (40%) for reagents, medical supplies, equipments (i.e. ambulance, ambubag, stretcher, etc.) information technology (IT) equipment specific for facility use needed to facilitate reporting and database build up), capacity building for staff, infrastructure or and other related use related and necessary for the delivery of required service including referral fees for diagnostic services if not available in the facility.

2.3.3 The remaining twenty percent (20%) shall be exclusively utilized as honoraria of staff of the PCB facility and for the improvement of their capabilities as would enable them to provide better health services:

- a. Ten percent (10%) for the physicians;**
- b. Five percent (5%) for other health professional staff of the facility; and**
- c. Five percent (5%) for non health professional/staff, including volunteers.**

SECTION 3. EFFECTIVITY. This Ordinance shall take effect immediately after approval and after the completion of the required posting or publication.




