**MUNICIPAL ORDINANCE NO. 2014 – 599**

**AN ORDINANCE CREATING THE TECHNICAL WORKING GROUP FOR THE REVISION OF THE REVENUE CODE OF 2008 OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE AND PROVIDING FUNDS THEREOF.**

WHEREAS, Section 191 of the Local Government Code of 1991 authorizes local government units to adjust tax rates, as prescribed by the said Code, not oftener than once every five years;

WHEREAS, the Revenue Code of 2008 of Solsona, Ilocos Norte needs revision or updating to enhance public service delivery relevant to the changing needs of time and circumstances;

WHEREAS, it is the policy of the municipality to create an environment favorable to local economic development;

WHEREAS, revising or updating the Code requires the participation of a group who has technical expertise on the matter ;

NOW THEREFORE, upon motion of Hon. Mimi T. Vicente-Pulicay , be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte duly assembled that:

**SECTION 1. TITLE.** There is hereby created AN ORDINANCE CREATING THE TECHNICAL WORKING GROUP FOR THE REVISION OF THE REVENUE CODE OF 2008 of the Municipality of Solsona, Ilocos Norte.

**SECTION 2. MANDATE.** The Technical Working Group shall carry out the updating or revision of the Revenue Code of the Municipality.

**SECTION 3. COMPOSITION.** The Technical Working Group for the revision of the Revenue Code of 2008 of Solsona, Ilocos Norte is hereby composed as follows:

**SECTION 4. POWERS AND FUNCTIONS.** The Technical Working Group shall have the following powers and functions:

- a. formulate policies, plans and programs for the effective revision of the Code;
- b. to identify other internal sources of revenue, and other local impositions;
- c. ensure that the Code has a good revenue structure;
- d. ensure that the Code has observed the fundamental principles of Local Taxation;
- e. to communicate to the heads of offices, agencies and instrumentalities of the government and stakeholders the impact of proposed provisions revised or updated;
- f. to cause the public hearing of the Revised Revenue Code ;
- g. perform other functions as may be necessary to carry out effectively the purposes and objectives of this ordinance.

**SECTION 5. FUNDING.** The amount of P100, 000.00 is hereby appropriated to be taken from the unappropriated surplus of the general fund of CY 2013.

**SECTION 6. EFFECTIVITY.** This Ordinance shall take effect immediately following its approval and its publication or posting.

Copies of this Municipal Ordinance shall be forwarded to the Sangguniang Panlalawigan, Provincial Capitol, Laoag City for their review and other offices and authorities concerned for their information and appropriate action;


