MUNICIPAL ORDINANCE 61

AN ORDINANCE AUTHORIZING IGNACIO PALACIO JR.  
TO COLLECT HONORARIUM FROM THE MUNICIPAL  
TREASURER IN THE AMOUNT OF THREE HUNDRED  
PESOS (P300.00) PER MONTH.

WHEREAS, Section 447, Sub-Section one, Roman Numeral Nine (IX) of R.A. 7160, authorize the payment of compensation to a qualified person not in the government service who fill up temporary vacancy or grant honorarium to any qualified official or employee designated to fill a temporary vacancy in a concurrent capacity, at the rate authorized by law;

WHEREAS, the position of Meat Inspector was vacated by Orlando Vilorio who tendered his voluntarily resignation last January, 1993;

WHEREAS, Ignacio Palacio Jr., Sanitary Inspector of Solsona was designated by the Local Chief Executive to perform the duties of Meat Inspector in addition to his duty as Sanitary Inspector;

WHEREFORE, upon motion of hon. Henry A. Batara, duly seconded by Hon. Refani, Hon. Vicente and Hon. Pascua, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that

Section 1 - That Ignacio Palacio Jr. is authorized to collect Honorarium from the Municipal Treasurer in the amount of THREE HUNDRED PESOS (P300.00) per month;

Section 2 - The authority to collect honorarium will end after the said vacant position shall have been filled up by the Municipal Mayor to a qualified applicant;

Section 3 - This Ordinance shall take effect retroactive from the time Mr. Palacio started to render services as Meat Inspector;


