MUNICIPAL ORDINANCE NO. 62

AN ORDINANCE CREATING THE POSITIONS OF THE  
DEVOLVED DEPARTMENT OF HEALTH.

WHEREAS, Republic Act 7160 hereinafter referred  
to as the Local Government Code of 1991 transfers the res-  
ponsibility for the delivery of basic services and facili-  
ties from the National Government Agencies (NGA's) concerned  
to the LGU;

WHEREAS, Executive Order 503 mandates the transfer  
of Assets and Personnel and the creation of equivalent posi-  
tions of the affected personnel to the LGU concerned;

WHEREFORE, on motion of Hon. Rogeric E. Teodoro,  
duly seconded by Hon. Pascua and Hon. Vicente, be it

ORDAINED, by the Sangguniang Bayan of Solsona,  
Ilocos Norte, that:

Section 1 - The positions of the devolved Depart-  
ment of Health are hereby created, to wit:

- a) 1 Municipal Health Officer
- b) 1 Municipal Health Nurse I
- c) 4 Midwives II
- d) Sanitation Inspection I

Section 2 - This Ordinance shall take effect after  
a lapse of ten (10) days from the day a copy of it is posted  
in a bulletin board and other conspicuous places;

ORDAINED, by the Sangguniang bayan of Solsona,  
Ilocos Norte, that

Section 1 - That Ignacio Balacio Jr. is authorized  
to collect honorarium from the Municipal Treasurer  
in the amount of Three thousand (P3,000.00) per month;

Section 2 - The authority to collect honorarium  
will end after the said vacant position shall have been  
filled up by the Municipal Mayor or a qualified applicant;

Section 3 - This Ordinance shall take effect retro-  
spective from the time Hon. Balacio started to render ser-  
vices as said Inspector;
